

Rules of the Jeppesen Marine Club created by Jeppesen Italia Srl, having offices in Massa 54100, Centro Direzionale Olidor Via Dorsale 9, scala B (hereinafter Jeppesen Marine)

### 1. Joining the Jeppesen Marine Club

- 1.1 All individuals of 18 years old or older are eligible for Jeppesen Marine Club membership by duly filling in the membership application form
- 1.2 You can ask to join the Jeppesen Marine Club by filling out the form properly and sending it by fax to +39 0585 794801. You shall become a valid member of Jeppesen Marine Club when the payment for membership fee is received by Jeppesen Italia Srl. The conditions and terms of membership in the Jeppesen Marine Club will in any case be those of the Rules published online on the site [www.jeppesen.com/lightmarine](http://www.jeppesen.com/lightmarine) at the date the membership request was received.

### 2. General Conditions

- 2.1 The members registered with the Jeppesen Marine Club (hereinafter, the "Members") at just € 94,80 VAT incl. per year enjoy a series of services and benefits, including:

Starting from the date of notice of those changes to the rules which imply a change in the rights and duties of the Member, the member will have the right to withdraw from Jeppesen Marine Club within 10 days after joining, by sending a return registered mail to Jeppesen Marine.

- 2.2 It is understood that the benefits / services for Club Jeppesen Marine Members hereinabove will be acknowledged on condition that the relevant payment is made.
- 2.3 The Member may withdraw from Jeppesen Marine Club within ten days after joining by sending a return registered mail to Jeppesen Marine Club. Should the Member decide to withdraw after the limit of ten days after joining the Jeppesen Marine Club, he must give notice by return registered mail to Jeppesen Marine. In such case, the effects of the withdrawal will become into effect three months after the notice of withdrawal, without prejudice to the right of Jeppesen Marine to withhold the price for the services provided, or to the right of the Member to be paid back, within 15 days of the coming into effect of the withdrawal, of the part of the price not withheld by Jeppesen Marine.
